My name is Karen Ann Kedroski. I live at 10,202 Cayuga Road, Dallas, Texas 75228. My cellular phone number is 214-546-0204. I am 26 years old and my date of birth is 5-5-74. I have completed 13 years of schooling. I can read, write, and understand the English language.

I testified at the trial of David Lynn Carpenter because I had been told by Matt Tolbert that he had killed a lady in the Pleasant Grove area of Dallas. I met Mr. Tolbert through some friends, Matt Hobson and Dori Bransford Bailey. Ms. Bailey is now living in Tennessee but is moving back to Texas. She did not know how to get in touch with Ms. Bailey.

Mr. Hobson was killed before the trial when he was at a red light and a car kept honking for him to go. When he did not, the people in the car behind him got out and stabbed him to death. I am not sure about his full name or the correct spelling. However he had lived off of Ferguson Road in Dallas.

I have epilepsy and that I had surgery to possibly repair a portion of my brain to control my seizures. After I had the surgery I suffered some memory loss. The surgery was prior to the trial. My mother, Loir Kedroski at 214-321-2356, can provide more information.

I remember the trial and some of the things that I said in the statement I gave to the police. If I gave a statement then I must have told the police about the incident involving Matt Tolbert.

I remember Matt Tolbert telling me that he had broke into this woman's house, robbed her, stabbed her, and watched her die. He told me that he cut her with a hunting knife with a serrated edge on the back of the blade. I do not remember where the offense occurred. As I read my statement at the trial I remembered some of the facts I had given to the police. I have been told that Mr. Tolbert now lives in Rowlett, Texas somewhere with his wife and daughter. When Mr. Tolbert told me about the stabbing, he sounded like he was proud of what he had done. At first I thought he was just joking about the stabbing. I don't remember when he had made the statement.

Matt Tolbert also raped me. I was about seventeen or eighteen years old. I am now twenty six years old. I did not immediately tell my mother about the rape but I did when I was late

on my period. No sexual examination was performed because I had waited so long in telling anyone. When I gave a statement to the police about the rape, I told them what Matt Tolbert had told me. I did not pursue the charges because I was afraid of Tolbert. He put a knife to my throat at the time of the assault. I does not remember if I gave two statements or put all of the information into one statement, but my mother would know. I was out of high school when the assault occurred.

Matt Tolbert and Matt Hobson were friends and they also ran around with a "Brian" who was killed in a traffic accident several years

I was not told anything about the facts of the case before the trail. I read in the paper about it after it was over. I was not happy about Mr. Carpenter being convicted.

I have never met David Lynn Carpenter nor seen him before the trial. When I was in the witness room at the court I was the only one in the room at the time.

The above statement is true and correct to the best of my knowledge as I have told Mr. Pendergraf.
